# Queenslander celebrated as FIA Volunteer of the Year

A Queensland mother has just taken out the prestigious Fundraising Institute Australia's National Volunteer of the Year 2011 Award.

At a gala event at the FIA's 34<sup>th</sup> International Fundraising Conference in Melbourne on Friday night, February 25, Ada Banks from Jimboomba in south-eastern Queensland was celebrated for her selfless volunteer work for Cancer Council Queensland.

"In this International Year of the Volunteer, the Fundraising Institute Australia (FIA) is delighted to recognise Ada - along with all volunteers in the charity sector," FIA CEO Chris McMillan said.

"Volunteers are the lifeblood of charities. Without volunteers, charities simply could not carry out the extent of work they do.

"The FIA award is one small way we can celebrate our volunteers and their positive impact on the community," Ms McMillan said.

Cancer Council Queensland's fundraising engagement manager Vicki James said Mrs Banks's individual involvement with events equated to more than \$300,000.

"But collectively, Ada's involvement in so many different, various events cannot be expressed in monetary value," Ms James said.

Cancer Council Queensland's Relay For Life state manager Natalie Wust said Mrs Banks had "greatly reduced the impact of cancer in Queensland over the past six years as a direct result of her involvement in Relay For Life".

Mrs Banks has also played instrumental roles for many years in several other Cancer Council Queensland fundraising and awareness raising events including the Jimboomba Daffodil Ball, Challenge for Cancer, Australia's Biggest Morning Tea and the SunSmart cancer prevention outdoor events.

Mrs Banks's passionate commitment to help find a cure for cancer and supporting those affected by cancer followed the tragic death of her own son from the disease 15 years ago.

Volunteering Australia CEO Cary Pedicini said fundraising was an aspect of volunteering that involved a significant number of volunteers.

"Our recently released National Survey of Volunteering Issues highlights that 24.8 per cent of respondents were involved in some way with 'fundraising and/or retail' reinforcing the significance of this area of volunteer work," Mr Pedicini said.

"Volunteering is such an important part of a socially inclusive society, and fundraising is vital work for so many not-for-profit organisations.

"Volunteering Australia is pleased to congratulate Ada Banks as the FIA Volunteer of the Year."

Mrs Banks was one of 12 recipients of FIA National Awards for Excellence in Fundraising 2011.

Other major award winners on Friday night were:

- Fundraising Campaign of the Year The Salvation Army (Victoria) for "Christopher's Letter".
- Arthur Venn Award Professional Fundraiser of the Year Melissa Smith, University of Technology, Sydney.
