### About the Northern Territory NFP Forum

In 2018 the inaugural forum was held not only to an audience of outstanding not for profit leaders, but also by the request for more opportunities for learning.

In our second year, we know that there is still so much more to explore surrounding the theme of Sustainability, Resilience and Leadership.

This one-day Forum is designed to equip the Territory's not for profit leaders with the tools and knowledge to effectively manage our organisations. The theme reflects the core attributes not for profits and their leaders need to thrive in an ever-changing landscape.

### Sustainability

Sustainability in a broad sense includes traditional practices of preserving our natural resources, through best practice models of governance to contemporary applications of leveraging technology and relationships to create more sustainable organisations. In the not for profit sector sustainability describes our ambition to achieve long term impact, through organisations that will continue to serve our communities for years to come.

### Resilience

As not for profits, we deal with some of the toughest and most complex social issues, alongside multiple stakeholders, whilst juggling financial and operational challenges within our organisations. Each of us needs to build our own personal and organisational resilience toolkit.

### Leadership

The information revolution has given us access to an infinite supply of resources to develop our leadership skills and styles, but no one person has the full kit bag. What are the leadership skills that are most critical for running a sustainable and resilient not for profit?

The Forum brings together speakers from the Northern Territory and interstate, each a leader in their field, with opportunities to share learning and connect with sector leaders from across the Northern Territory.

## About our speakers and organising committee



### **Bilawara Lee (Aunty B), Larrakia Elder**

Bilawara is an Elder of the Larrakia Nation; she was born in Darwin and has lived here for nearly 68 years as member of the large respected Cubillo family. She is the Larrakia Academic in Residence at Charles Darwin University and is an international published author with two books 'Star Dreaming' and 'Healing from the Dilly Bag.'

Bilawara is internationally respected as a healer and teacher of the ancient wisdoms of Aboriginal Spirituality and Healing, and travels nationally and internationally to conduct special life-changing workshops and ceremonies. She is dedicated to helping the wider community understand First Nations Peoples connection to country, culture and community.



### **John Hender, National Manager Native Title, Perpetual Private**

John has extensive experience working with Aboriginal Trusts and communities across Australia. His strong understanding of Aboriginal culture and issues has been strengthened by his current tertiary education in a Masters of Aboriginal Studies at University of South Australia.

John has 30 years experience in the financial services industry. He has held roles in sales and marketing, consulting and business development. For the past 15 years he has held senior regional executive roles as SA and NT State Manager for AMP and most recently as SA State Manager for Perpetual Private.

John has held various board positions including make A Wish Foundation's national and international Boards and The Medical Research Foundation in SA. He is currently on the board of Foundation for Australia's Most Endangered. John has tertiary qualifications in marketing, superannuation and trust management, insurance and Aboriginal studies.

John will be sharing around leadership and resilience of Indigenous communities through the lens of Perpetual and the national body of work undertaken through Trusts.



### **Suzanne Waldron, M.A., ICF PCC, MAN LP, FAIM Behavioural and Leadership Facilitator**

Suzanne is a behavioural change facilitator whose masters research focused on moving ideas into action through pro-social leadership. Working with senior leaders across Australia her focus is on explicit communication and solid peer to peer relationships. She's an active ambassador for RUOK?, TEDxPerth Curator and Co-founder/director of short doco series Stories Out Loud. A published author and media contributor. Suzanne has been nominated for Western Australian of the Year 2016 and twice 40 under 40.

Suzanne will be sharing on leadership and resilience of communities through your lens of her work through the RUOK campaign.



### **Dion Devow, Managing Director- YERRA & ACT Australian of the Year 2018**

Dion was born and raised in Darwin and is of both Aboriginal and Torres Strait Islander descent and is Traditional Owner for the Palm Island Group of Northern Queensland, (Manbarra) and also has heritage that stems from Darnley Island in the Torres Straits. Dion has a Bachelor of Applied Science in Health Education and has supported Aboriginal and Torres Strait Islander people's access to health, justice, and education for more than 20 years in Canberra ACT.

Dion worked as a Member of the ACT Aboriginal and Torres Strait Islander Education Consultative Group from 2009 to 2014 and for much of that time was the Deputy Chair, and has recently been elected to the ACT Aboriginal and Torres Strait Islander Elected Body ([www.atsieb.com.au](http://www.atsieb.com.au)).

Dion uses this 20 years of experience to work as a consultant specialising in community

engagement within Health, Education, Justice and is now consulting within the Business sector to assist Aboriginal and Torres Strait Islander people to reach their dreams and aspirations with respect to business.

Dion is recipient of the 2018 ACT Australian of the Year, winner of the 2014 ACT NAIDOC Business of The Year, and the 2016 ACT NAIDOC Person of The Year, Dion is also the ACT representative for the First Australians Chamber of Commerce and Industry.

Dion will be sharing an insight into his time growing up in Darwin and the journey he took to get to where he is today an Indigenous Entrepreneur and the 2018 Indigenous Australian of the Year. Dion will also share his experiences as being a volunteer and how that role helped him through his journey.

Rachael is a member of the Forum organising committee.



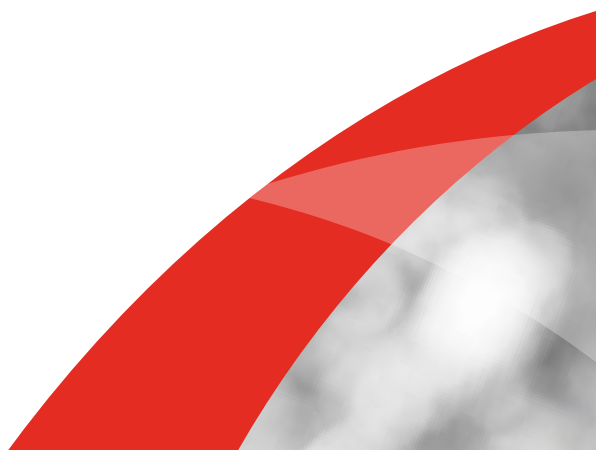
**Karen Glazbrook, Manager
