# FIA Fellowship Guidelines



This guide provides information to those fundraising professionals who are nominating a member for Fellowship of FIA.

# What does being an FIA Fellow mean?

#### A celebration of distinguished service!

FIA promotes excellence in fundraising by recognising the achievements of our members in their drive to be the best they can be as fundraising professionals. FIA membership acknowledges commitment to best practice in one's career as a professional fundraiser. Members are signatory to FIA's Code and therefore uphold the highest ethical and professional standards of fundraising.

Our constitution acknowledges distinguished service by FIA members and celebrates their careers and contribution to society through the member journey.

Members who have been awarded Fellow of FIA status are entitled to use the FFIA (Fellow, FIA) designation after their name to highlight their achievement.

# **Criteria for Fellowship**

To be eligible they must:

- 1) be an FIA member
- 2) have 10 years' service in the sector
- 3) demonstrated contributions to the sector
- 4) demonstrated achievements through their career
- 5) be a 'fit and proper' person in the view of the FIA board, having:
  - a. completed the FIA Code Course and demonstrated support of the FIA Code
  - b. continued professional development
  - c. demonstrated good conduct

# Who can submit a Fellowship nomination form?

Candidates must be nominated by a member and supported by an additional FIA member.

# Who can be nominated?

Any member of FIA who meets the criteria.

Members may not nominate themselves.

The process is kept confidential from the member being nominated.

# Nomination conferment process

Nominations are assessed by a peer-based committee, selected for set terms by the CEO, and then forwarded to the FIA board for final approval.

Before nominations are considered, FIA will undertake a routine membership check on nominees including length of years in the sector, continued professional development, and any issues relating to their membership. These checks will be undertaken prior to the nomination being fully considered by the Fellow's committee. Should these checks identify any issues in these areas, then the nomination may be declined.

# Fellows criteria – for a member to qualify they must:

- 1) be an FIA member
- 2) have 10 years' service in the sector
- 3) demonstrated contributions to the sector
- 4) demonstrated achievements through their career
- 5) be a 'fit and proper' person in the view of the FIA board, having:
  - a. completed the FIA Code Course and demonstrated support of the FIA Code
    - b. continued professional development
    - c. demonstrated good conduct

PLEASE NOTE: A membership check will be undertaken as evidence of the nominee being a 'fit and proper person' to receive a Fellowship. If this cannot be supported the nomination may be declined.
