

FIA Emeritus Guidelines

Election as a Fellow Emeritus or Member Emeritus of Fundraising Institute Australia (FIA) is a professional honour that is awarded following intense review and reflection by one's peers. In completing the details for your nominee you should keep in mind that the information you provide is the basis for the consideration of this nomination. To be eligible for election as a Fellow/Member Emeritus, an FIA member must meet the requirements as detailed in Clause 20 of the FIA Constitution:

EMERITUS MEMBER

- (a) A Fellow Emeritus or Member Emeritus shall be a former Regular, Executive or Fellow of the Company who has retired after long and active participation in fundraising and who at the discretion of the Board has been so designated in recognition of esteemed membership of the Company. A Fellow Emeritus or Member Emeritus as such has no voting rights nor shall they be part of a quorum.
- (b) A nomination of a person for election as a Fellow Emeritus or Member Emeritus shall be in a form prescribed by the Board. Upon receipt of any such nomination the Secretary shall forward a copy of the nomination to each member of the Board and the decision whether or not to recommend such nominee for designation as a Fellow Emeritus or Member Emeritus by election shall be made at the next Board meeting.
- (c) A Member Emeritus who at the time of gaining that status is a Fellow of the Company shall continue to be designated a Fellow of the Company.
- (d) A Member Emeritus/Fellow Emeritus shall have no obligation to pay annual Subscriptions.

Nomination Conditions

1. Nominations should be made in confidence and not divulged to the nominee.
2. Nominations will be elected by members at the next FIA Annual General Meeting.
3. Nominators will be advised in early December of the outcome of their nominations.
4. Note that your nomination of a member for consideration as a Fellow or Member Emeritus of FIA must be supported by another member of FIA.

SECTION 3 CRITERIA FOR MEMBER EMERITUS

Emeritus criteria – for a retired former member to qualify they must:

- 1) Have been a long standing FIA member
- 2) Have made demonstrated contributions to the sector
- 3) Demonstrated achievements through their career
- 4) Be a 'fit and proper' person in the view of the FIA Board, having:
 - a. Demonstrated support of the FIA Code
 - b. Demonstrated good conduct

PLEASE NOTE: A membership check will be undertaken as evidence of the nominee being a 'fit and proper person'. If this cannot be supported the nomination may be declined.
