The role

As the Fundraising Manager in a small and dynamic organisation you will be responsible for the execution of the individual giving growth strategy and the development of new channels and systems to optimise our long-term fundraising revenue and ROI.

The ideal candidate will be passionate about our vision, have a strong track record in developing and executing successful individual giving acquisition and retention campaigns and thrive on continual learning and achieving results.

You will be confident in creating long-term growth and retention strategies, developing fundraising investment business cases and presenting to the Board. In this role, you will manage a small team helping to ensure targets and deadlines are met and systems are optimised and integrated. Your work will involve close collaboration with the campaigns team and external agencies to achieve high-quality results and fundraising performance

in line with the budget. You will report to the CEO and be part of the organisation's leadership team.

Main Duties and Responsibilities

Develop, execute and track fundraising budgets including strategic investments to grow fundraising programs.

Oversee the long-term acquisition investment for growing the Animal Defender monthly regular giving program.

Develop and implement a multi-year strategy for Philanthropy programs—Gift in Wills, Major Donor, Trusts, Foundations and Partnerships.

Manage and enhance the existing mail appeals and newsletter program to optimise engagement and results.

Produce detailed, regular reporting for the CEO, Finance Manager and Board on fundraising campaign outcomes against budgets.

Work closely with the Communications Manager and Digital Marketing/Social Media coordinator to promote fundraising messages and objectives across all channels.

Using a holistic approach for integrated campaigns including front and back-end processes to optimise outcomes, analysis and reporting.

Work with external agencies to develop and optimise fundraising programs.

Manager and mentor a small fundraising team.

Work collaboratively with the campaigns team to optimise donor engagement.
